

The 19<sup>th</sup> Session of the 3<sup>rd</sup> Year of the 25<sup>th</sup> House of Representatives  
(Second Annual Ordinary Session)



On 22<sup>nd</sup> December 2021, at the House of Representatives Chamber, Parliament Building, Mr. Chuan Leekpai, Speaker of the House of Representatives, presided over the 19<sup>th</sup> Session of the 3<sup>rd</sup> Year of the 25<sup>th</sup> House of Representatives (Second Annual Ordinary Session) with Mr. Suchart Tancharoen, First Deputy Speaker of the House of Representatives, and Mr. Supachai Phosu, Second Deputy Speaker of the House of Representatives, served as the chair of the sitting in rotation.

The sitting considered the important matters in accordance with the agenda, as follows:

**Matters that the committees have considered**

1. Draft Bill on Judicial Service of the Courts of Justice (No..), B.E. ..
2. Draft Bill on Juvenile and Family Court and Procedure (No..), B.E. ..
3. Draft Bill on Establishment of Labour Courts and Labour Court Procedure (No..), B.E. ..
4. Draft Bill on the Establishment of and Procedure for Intellectual Property and International Trade Court (No..), B.E. ..

The sitting resolved to approve these 4 Draft Bills in the third reading for submission to the Senate for further consideration and to approve 4 committees' observations for notification to the Council of Ministers for further consideration and proceeding.

#### **Urgent Matters**

1. Draft Bill on the Most Illustrious Order of Chula Chom Klao (No..), B.E. ..., proposed by the Council of Ministers.

The sitting approved in the third reading for submission to the Senate for further consideration.

2. Draft Bill on Government Pension Fund (No..), B.E. ..., proposed by the Council of Ministers and it approved to consider Draft Bill on Government Pension Fund (No..), B.E. .. and this Draft Bill altogether.

The sitting resolved to adopt the principles of both Draft Bills and establish the Ad-hoc committee on considering the Draft Bills, which is composed of 25 members. The Draft Bill proposed by the Council of Ministers was the major Draft Bill for consideration and the time limit for the amendment to motions was set within 15 days.

#### **Matters pending consideration**

1. Draft Bill on Arbitration (No..), B.E. ..

The sitting resolved to approve that the Council of Ministers received such Draft Bill for consideration prior to the adoption of its principle within 60 days.

2. Draft Bill Amending Emergency Decree on the Provision of Financial Assistance for Entrepreneurs Affected by Covid-19 Pandemic, B.E.2563 (No..), B.E. .. and approved to consider other 4 Draft Bills having similar nature altogether, namely,

1) Draft Bill Amending Emergency Decree on the Maintenance of Stability of the Financial System and Economic Security of the Country, B.E.2563 (No..), B.E. ..

2) Draft Bill Amending Emergency Decree on Authorising the Ministry of Finance to Raise Loans to Solve Problems, to Remedy and Restore the Economy and Society as Affected by the Coronavirus Disease Pandemic, B.E.2563 (No..), B.E. ..

3) Draft Bill Amending Emergency Decree on the Provision of Financial Assistance for Entrepreneurs Affected by Covid-19 Pandemic, B.E.2563 (No..), B.E. ..

4) Draft Bill Amending Emergency Decree on the Provision of Financial Assistance for Entrepreneurs Affected by Covid-19 Pandemic, B.E.2563 B.E. ..

The Council of Ministers asked for the receipt of 5 such Draft Bills for consideration prior to the adoption of their principles. The time limit for the consideration was set for 60 days.

3. Draft Bill on Narcotic (No..), B.E. ..

The proponent asked for the withdrawal of such Draft Bill from the agenda.
