#### Issue of consideration

- 1. The content should be added in the principle of the Draft Constitution of the Kingdom of Thailand Amendment (No. ..) Buddhist Era ....in order to make clear that it would not be any change in the part of the King Chapter, the Constitutional Organs, and the Courts, as it had considered.
- 2. The wording should be corrected in the principle from "the new draft Constitution" to be "the Draft Constitution of the Kingdom of Thailand Amendment (No. ..) Buddhist Era ...." because the article 291(2) concerning amendment of the Constitution explicitly formulated that motions for amendment must be proposed as draft constitution and the parliament would consider in 3 readings. For this reason, the amendment of the constitution drafted by the whole cannot be done. Therefore, in order to conform to the principles of article 291 (2), the wording should be corrected in order not to conflict with the principle of article 291.
- 3. Modifying principles by adding contents and adjusting words as proposed in item 1 and 2 can be done or not.

# Issue of consideration

- 1. Paragraph (17) should be cut out because the Constitution Drafting Assembly (CDA) should be elected directly by citizens across the country solely. So that this Constitution will be a truly democratic. And to prevent the accusation that the CDA being selected by the meeting of the Parliament has already specified its members by a majority vote of the Parliament.
- 2. Paragraph (18) should be cut out, because if it is remained, it will be possible to rewrite the new constitution at any time, which is not a valid principle. In case the referendum does not accept the new draft constitution (which will be completed), and it cause the new draft constitution fall, thus, no motion should be allowed to present to the Parliament's resolution to prepare a new constitution once again.
